PETITIONS FROM THE PUBLIC

Adam Schweitzer thanked City Clerk Lampe for her assistance in obtaining copies of records requested, the other Clerks in the office with their professionalism, and Police Chief Niedert for answering additional questions. Mr. Schweitzer asked questions regarding the events that occurred July 1st – 4th. If monies were exchanged between the organizations in charge and the City for use of location and staff to assist in setting up for the events. Why do some people have to pay to rent the Bandshell and some do not? City Manager Roder replied that question is more of a policy question, and this is not the appropriate time and place to talk about that but can be discussed privately. Mr. Schweitzer then asked questions and made comments regarding the Chamber of Commerce and the Chamber's transparency.

HEARINGS & ORDINANCES

Council Member Jensen with a motion to set a date of July 25, 2022, at 5:00 pm for a public hearing to create Code Section 69.30 Loading Zones, second by Council Member Callahan. City Manager Roder shared that this will create a loading zone from the intersection of 1st Street East and 4th Avenue NE on the east side going north to the first driveway to the east. Council asked questions regarding how this would be marked/designated so people know it is not a normal parking area. Ayes: All.

RESOLUTIONS

Council Member Jensen with a motion to approve the updated Council Rules of Procedure, second by Council Member Prusator. The roll being called the following Council Members voted: Ayes: Huston, Hanna, Kurtz, Prusator, O'Loughlin, Jensen, and Callahan.

Resolution adopted and upon approval by Mayor assigned No. 2022-98 in the Official Book of Resolutions.

Council Member Callahan with a motion to approve a resolution that replaces and repeals Resolution 2022-06 that sets the mileage reimbursement rate, second by Council Member Hanna. The roll being called the following Council Members voted: Ayes: Hanna, Kurtz, Prusator, O'Loughlin, Jensen, Callahan, and Huston.

Resolution adopted and upon approval by Mayor assigned No. 2022-99 in the Official Book of Resolutions.

Council Member Callahan with a motion to approve a resolution to assess a property owner for Chapter 52 Mowing of Properties – Failure to Comply, second by Council Member O'Loughlin. The roll being called the following Council Members voted: Ayes: Kurtz, Prusator, O'Loughlin, Jensen, Callahan, Huston, and Hanna.

Resolution adopted and upon approval by Mayor assigned No. 2022-100 in the Official Book of Resolutions.

OTHER BUSINESS

Council Member Huston with a motion to approve the annual renewal of the home occupation permit for Etten Vinyl & Graphics, LLC, second by Council Member Hanna. City Clerk/Treasurer Lampe explained Mr. Etten had missed the deadline for turning in the renewal form and turned it in after the June 27th City Council meeting where the others were approved. The roll being called the following Council Members voted: Ayes: Prusator, O'Loughlin, Jensen, Callahan, Huston, Hanna, and Kurtz.

Council Member Callahan with a motion to approve a three-year lease of property located at 109 3rd Ave NW, second by Council Member Jensen. City Manager Roder explained this is changing the person leasing the property as this property has been previously leased. The roll being called the following Council Members voted: Ayes: O'Loughlin, Jensen, Callahan, Huston, Hanna, Kurtz, and Prusator.

Council Member Jensen with a motion to allow Innovative Ag Services to have a holding tank installed, second by Council Member Hanna. Council Member O'Loughlin asked why they didn't want to connect into existing lines. City Manager Roder replied they are roughly 200 feet away from the nearest connection and it would require concrete to be ripped up to make the connection. City staff did reach out to Chad Beatty with Buchanan County to check on what could be installed, either a small septic tank or holding tank. Innovative Ag is planning on installing a scale and scale house where they just tore a building down. The scale house would have a restroom which would require the septic tank/holding tank. The roll being called the following Council Members voted: Ayes: Jensen, Callahan, Huston, Hanna, Kurtz, Prusator, and O'Loughlin.

Council Member Jensen with a motion to enter into an agreement with HUB for third party administrator services, second by Council Member Prusator. City Manager Roder explained HUB would provide the same services for benefits that Alera Group currently provides for the City. There is no cost impact to the City with this change. The roll being called the following Council Members voted: Ayes: Callahan, Huston, Hanna, Kurtz, Prusator, O'Loughlin, and Jensen.

Council Member O'Loughlin with a motion to approve the Airport Manager to dispose of the 2004 Chevrolet Venture, second by Council Member Callahan. The roll being called the following Council Members voted: Ayes: Huston, Hanna, Kurtz, Prusator, O'Loughlin, Jensen, and Callahan.

Council Member Callahan with a motion to approve the revised Façade Project – Asbestos Abatement removal contract with ECCO Midwest, Inc., second by Council Member Prusator. Council Member O'Loughlin asked questions regarding the City's involvement for the asbestos removal for the project. City Manager Roder explained asbestos removal was planned to be a part of the project and was built into the contingency funds. The roll being called the following Council Members voted: Ayes: Hanna, Kurtz, Prusator, O'Loughlin, Jensen, Callahan, and Huston.

Mark Crawford, Crawford Engineering, spoke on the Highway 150 Phase 2 Reconstruction Project and the Liberty Trail South Extension Project. Mayor Pro Tem Kurtz asked if there could be anything done to allow for easier access to Oakwood Cemetery for the tour this Saturday. Council Member Jensen asked if the City had a comprehensive trail plan for future trail projects.

REPORTS

The following comments were heard from Council and Staff: Callahan- Has heard lots of positive comments about Independence with the Our Town segments. Huston- Very positive for the 4th of July weekend. Hanna- Received a phone call from an individual who had received a speeding ticket by the school and had questions regarding the flashing lights not being on. Asked for clarification on yard nuisances and who should Council contact. Kurtz-Reminded everyone about the upcoming election on July 19th. Early voting can be done at the Buchanan County Auditor's office and then on July 19th, the voting will be held at the Falcon Civic Center. Thanked everyone that helped with the 175th Celebration and all the events over the July 4th weekend. Has heard lots of positive things. Jensen- The 4th of July was wonderful. Very impressed with how City Staff responded and had lots of the down tree branches already off the streets. City Manager- Council should contact himself or Building Inspector/Code Enforcement Officer Sherrets directly with any yard nuisances. City Clerk- City Code Chapter 75 changes that were talked about at the Committee of the Whole meeting will be addressed in the 2022 Legislative Update that should be coming out later this week or next week. Police- All speeding tickets are reviewed before the ticket is mailed out. If people have questions, they are encouraged to contact the Police Department. Had a meeting with Street Superintendent Esch and Crawford Engineering regarding parking and traffic for businesses along the 300 block of 1st Street E once the Highway 150 Phase 2 Reconstruction Project reaches Segment 3.
