City Manager- Council received a letter from an out of state individual that was unhappy with the camera on 1st Street West and said there needs to be signs there. City Manager Roder drove that area and said the signs are still there that have been up since the camera was installed. June 17th is the Chamber golf outing for those interested. Reminded everyone that June 11th is City Wide Clean up. Kurtz- Encouraged people to reach out to others to take out nomination papers for the mayor election once they are available.
